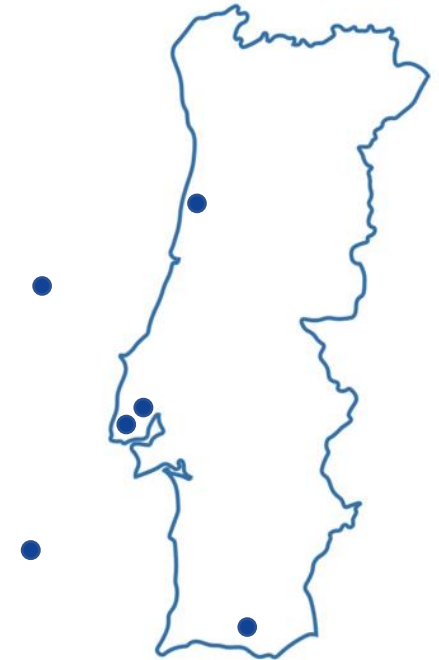

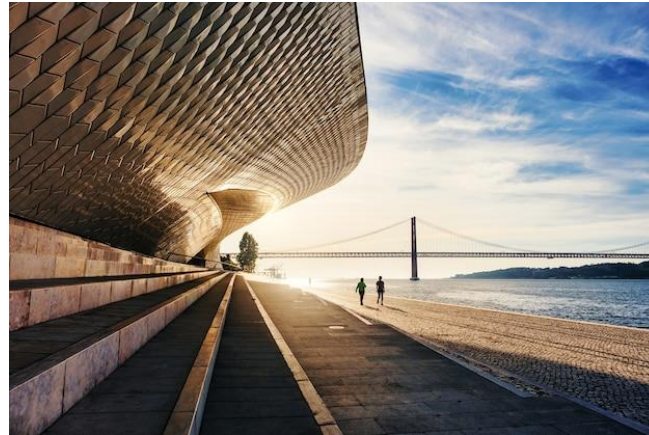

- Our worldwide network and professional team enables safe, fast and effective solutions.

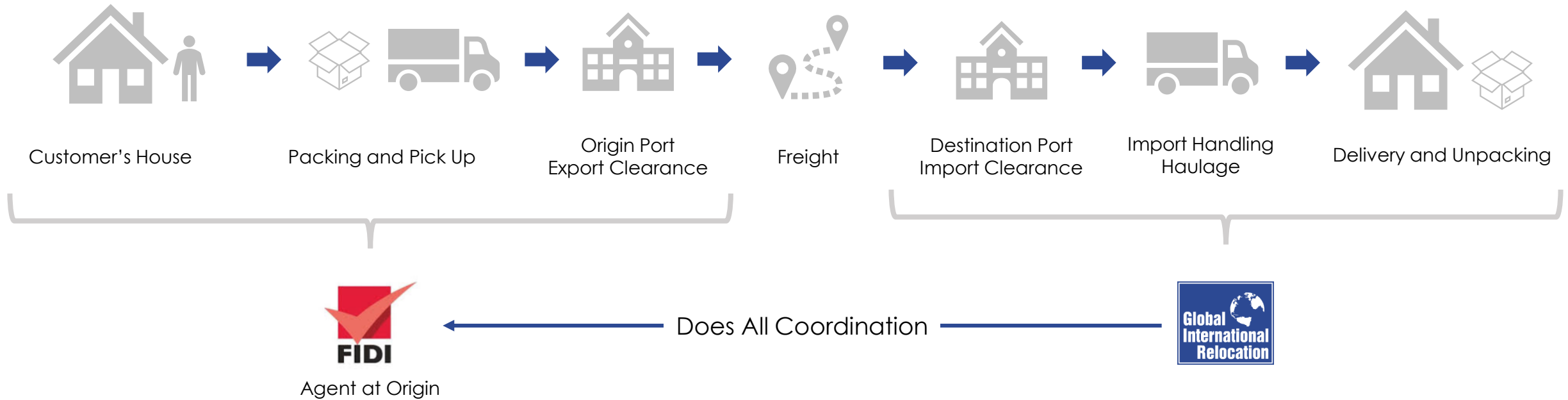
By Road

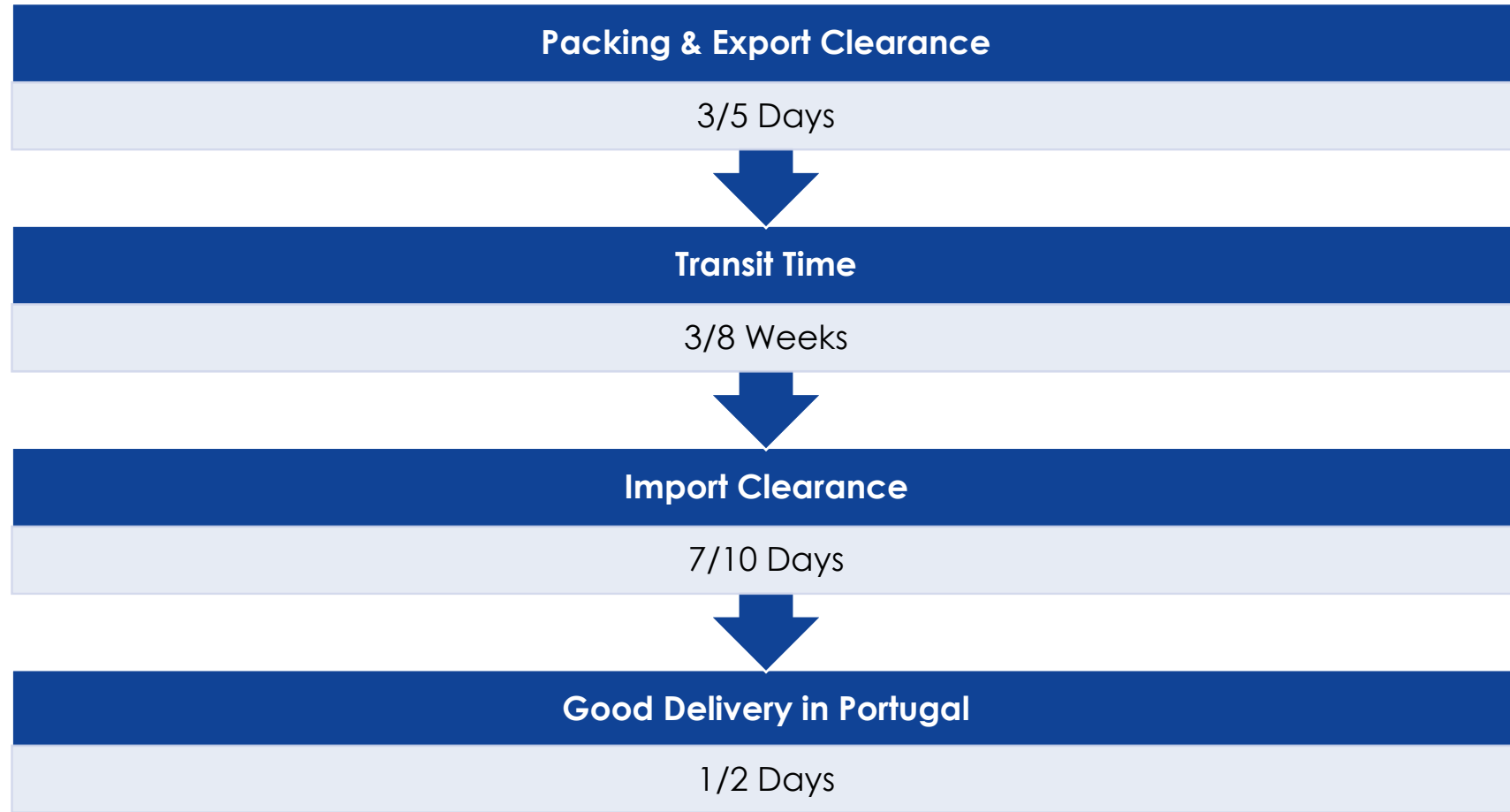
Documents for Export Clearance

- Passport
- Power of Attorney on the name of the broker
- Inventory (will come out of the packing list)
- Commercial value of the goods (is set by the client)

Note: This is a generic list. Depending on the country where the goods will be shipped from more documents may be required for the export clearance.

Ports of Arrival

Depending on the area of Portugal where you are going to move, we will receive your goods at one of the ports



Oporto: Port of Leixões



Lisbon: Port of Lisbon



Algarve: Port of Sines

Process For Clearance in Portugal

Option With Tax Exemption

To access this option, there are some rules and documents that you will have to comply with:

- Shipper must have proof that he's lived in the origin country for the last 12 months;
- Luggage Certificate
- Portuguese Residence certificate
- Portuguese Tax Number
- Goods declaration
- Passport



Process For Clearance in Portugal

Option With Tax and Duties Payment

This process is simpler, but taxes and duties are charged. To access this option:

- Goods declaration
- Passport



Note:

The value of the taxes and duties on average are:

VAT: 23% of the declared value of the goods + the freight cost;

DUTIES: Varies between the 6/16% of the declared value of the goods + the freight cost + VAT;

Example:

VAT: Freight Cost (1000€) + Declared value of the goods (5000€) =
6000€ x 23% = 1380€

DUTIES: Freight Cost (1000€) + Declared value of the goods (5000€) +
VAT (1380€) = 7380€ x 11% (average dutie percentagem) = 811,8€

TOTAL: 2191,8€

Containers

Types



20" Container: Up to 30m³

- 1 bedroom apartment: 15m³;
- 2/3 bedroom small apartment: 30m³;
- 1 standard car can fill a 20" container;

40" Container: Up to 60m³

- 4+ bedroom house can have between 40m³ to 60m³;

40" (High Cube) Container

- Taller container that fits up to 70m³;

Shared Container

- For loads smaller than 10m³;

Insurance

Protect Your Goods

- **Carrier Liability**

Its the a basic insurance, that covers any damages occurred during packing, it does not cover in transit damages.

- **Total Loss Coverage**

Your entire shipment must be lost, destroyed or damaged for this type of coverage to apply.

- **All Risk Cargo Insurance**

The safest option, covers any possible loss or damage during transit, covers non delivery of the goods or improper storage by shipping company. Comprehensive list of replacement value is needed.



Note: Smaller items such as expensive jewelry or importante documents should always travel with the shipper and not as cargo, as insurance will not cover it.

Import Limitations

What You Can't Bring

Alcohol

- Lisbon: Limit of 1,5 liters of any type of alcohol;
- Oporto and Algarve: No alcohol;

Fur

- It must have the CITES certificate for import into the EU of rare species;

Weapons

- Not permitted;

Medicines

- Not permitted;

Vehicles

- Cars, boats, motorcycles. Up to one vehicle can be exempt of tax per person. (The vehicle needs to be owned for at least 1 year.)



Inspections

Authority Check

An **inspection can carry delays** in the clearance process **and extra costs** such as demurrage and port storage.

Shipments with most inspections usually come from South America and Asia, but no one is exempt from having an inspection.



Types of Inspection:

- **Simple**
X-rays and opens a random box;
- **Intermediate**
Partial inspection of the container;
- **Total**
Inspection for full container;
